## **FIRST PARTY:**

- a) The Copyright of any publication by Men-Tsee-Khang shall remain exclusively with Men-Tsee-Khang.
- b) Right to purchase published book at a discount of 50% from the retail price.
- c) Right to sell published book at retail price or at a discount to its well-wishers, staff and students.
- d) Right to terminate the contract if the Second Party is not able to follow the terms and condition of the agreement.

#### **SECOND PARTY:**

- a) Exclusive Right: The exclusive right in Russian Language for publishing, distributing and promoting the sale of the book but has to bear all the expenses by them self.
- b) Retail Selling Price (MRP): The right to fix the MRP of book but it should be reasonable.
- c) Cover Design & Book Format: Has the right to make decision on cover design & format of the book.
- d) Consent: Have to seek the permission from **First Party** for reprinting, modification, or any other changes on published book.
- e) Royalty: Have to pay 5% of the net profit of each sold book along with sale report at the end of the each financial year.
- f) Complimentary Copy: Have to provide 25 copies of the published book to the First Party at free of cost.
- g) Manuscript and Soft copy: It is mandatory to submit to the **First Party** a copy of the typed manuscript and soft copy along with any photographs, diagrams, maps and any other material to illustrate the work without charges.

#### **TERMS OF PAYMENT**
